OPTION ONE – GRACE TUITION CREDIT AND 3RD SOURCE FUNDRAISING

Rebate will be distributed 47% tuition credit, 47% 3rd source fundraising, and 6% administrative fee.

(Note: if your tuition credit for any distribution period is less than \$5, your credit will be applied to your fundraising goal)

OPTION TWO – 3RD SOURCE FUNDRAISING (Waive tuition credit)

Rebate will be distributed 94% 3rd source fundraising and 6% administrative fee.

OPTION THREE – TRANSFER TO A DIFFERENT ST. BERNARD SCHOOL OR NDA FAMILY

The rebate will be distributed in accordance with the family's St. Bernard Scrip Agreement.

OPTION THREE – UNRESTRICTED CONTRIBUTION TO ST. BERNARD PARISH

Rebate will be distributed 94% St. Bernard Parish and 6% administrative fee.

You can designate your contribution by **choosing one of the options** for the distribution of the scrip rebates generated from your purchases. Your designation will remain in effect for May 1, 2022 through April 30, 2023 or until a different Scrip Agreement Form is completed and recorded.

Scrip tuition credit distribution schedule:

Distribution 1: **January, 2023** - for earnings from May 1 to December 31, 2022

Distribution 2: **May, 2023** - for earnings from January 1 to April 30, 2023

Distribution 1 is applied to your family's unpaid tuition obligation for the 2022-23 school year unless you choose to waive the tuition credit.

Distribution 2 is applied to your family's unpaid tuition obligation for the 2023-24 school year unless you choose to waive the tuition credit.

The **fundraising portion of both distributions** for St. Bernard School families is applied to the 2022-23 St. Bernard Academic Year.

Site Participation Requirements

1. SCRIP Purchase Agreement

Optional. Proceeds from SCRIP purchases will be split 45/45/10 (45 to the family, 45 to the school and 10 to the SCRIP Program for administrative fees). The family portion will be applied in the form of a family tuition credit.

- SCRIP credits earned will go toward your family fundraising goal of \$400. See Site Fundraising Agreement.

2. Site Fundraising Agreement

It is expected that families commit to a Third Source Funding goal of \$400 profit per family.

- Profit not achieved will be billed and must be paid no later than May 13, 2023.

The other option is to opt-out of site fundraising and agree to pay \$400 which will be added to your tuition plan.

3. Service Hours Agreement

It is expected that families commit to working a minimum of 15 volunteer hours at school-related events during the 2022-23 school year as follows:

- A. Five (5) hours must be volunteer hours at fundraising events such as Auction for Education or SCRIP Sales/SCRIP Volunteering, or other SAC-approved school fundraising events not specific to sports/extracurricular events. Hours not worked will be billed at a rate of \$30 per hour to be paid no later than May 13, 2023.
- B. Ten (10) hours must be general volunteer hours. Hours not worked will be billed at a rate of \$20 per hour and must be paid no later than May 13, 2023.

The other option is to opt out of service hours and pay \$350 which will be added to your tuition plan.

GRACE Site: **St. Bernard Catholic School**

Grades/Program: **Preschool**

1. SCRIP Purchase Agreement

Optional. Proceeds from SCRIP purchases will be split 45/45/10 (45 to the family, 45 to the school and 10 to the SCRIP Program for administrative fees). The family portion will be applied in the form of a family tuition credit.

- SCRIP credits earned will go toward your family fundraising goal of \$100. See Site Fundraising Agreement.

2. Site Fundraising Agreement

It is expected that families commit to a Third Source Funding goal of \$100 profit per family. Profit not achieved will be billed and must be paid no later than May 13, 2023.

The other option is to opt-out of site fundraising and agree to pay \$100 which will be added to your tuition plan.

3. Service Hours Agreement

It is expected that families commit to working a minimum of five (5) volunteer hours at school-related events during the 2022-23 school year. Hours not worked will be billed at a rate of \$20 per hour and must be paid no later than May 13, 2023.
